If the fees determined and finally approved by the Authority is less than the adhoc fees then the difference in the amount of fees shall be refunded by such institutions/colleges to the concerned student/students.

If the fees determined and finally approved by the Authority is more than the adhoc fees then the difference in the amount of fees shall be recovered by such institutions/colleges to the concerned student/students".
